

Assange lands in Australia a free man

Julian Assange, the **founder** of Wikileaks, returned to Australia after a **plea deal** allowed him to leave a London prison. At Canberra Airport, he had an **emotional reunion** with his wife and father, with his lawyers watching. His wife, Stella, said that Julian needs time to recover and adjust to freedom.

For 14 years, Assange has been in a **legal battle** with the US, **accused** of **leaking** secret documents that **endangered** lives. He did not attend the news **conference** in Canberra, letting his wife and lawyer speak for him. They emphasized the need for family time.

Assange and Stella married in Belmarsh prison in 2022 and have two children. The plea deal had him plead guilty to one charge of **conspiracy**, instead of the original 18 charges. This was related to Wikileaks' 2010 release of a US military video and documents showing civilian deaths in Iraq and Afghanistan.

Assange's lawyer called the deal a threat to journalism, and Stella hopes people see the danger in this case. Assange spent five years in Belmarsh Prison and seven years hiding in Ecuador's London embassy. He also faced rape and sexual assault charges in Sweden, which were dropped in 2019 due to the passage of time. Swedish women's rights groups regret he was never questioned over these allegations.
